




# \*Documents Checklist For Temporary Resident Visa :

**Documents Required For Main Applicant :** 

- Passport
  - Recent
  - 🗌 Old
- Digital Passport Size Photos

□ The frame size must be at least 35 mm x 45 mm (1 3/8" x 1 3/4"). The photographs must show the full front view of the head, with the face in the middle of the photograph, and include the top of the shoulders.
The size of the head, from chin to crown, must be between 31 mm (1 1/4") and 36 mm (1 7/16").

(You Must Include Proof That You Can Support Yourself And Family Members Accompanying You While You Are In Canada As Well As Your Financial Establishment In Your Home Country)

- Bank Saving

- Affidavit Of Support (If Parents Or In-laws Are Sponsoring)
- Evidence Of Property Owned
  - Fixed Asset Valuation:

- □ Appointment Letter (Showing Duration, Duties & Designation)
- □ Work Experience Letter
- □ Salary Slip Of Last 6 Months
